Firstly, the board was very honoured to be included in a Federal Strategies Statement submitted to federal government officials in Fall 2019. Secondly, the board distributed and analyzed membership responses to a survey and this resulted in maintaining some past events such as the social gatherings. The gathered information from the survey was instrumental to start drafting strategic development plan we hope to release to the membership before the end of the year. Thank you Renai for your work with me on this draft. Thirdly, we were successful in recruiting a public relations officer in October 2019 to lead our social media platform. the role. Fourthly, our student member at large, Nicole G, recommended that we address some student questions about starting a career in ABA or how to acquire supervision in Alberta. From her idea a panel discussion was held, entirely planned and managed by our student committee. The panel event was well attended by approximately 30 people in person and 13 people online. Thank you Nicole G for suggesting and guiding a successful event and to your co-presenter Tayt Garbutt. Lastly, the entire board, with the guidance of our governance training committee, finalized many Board operational documents such as the roles and responsibilities for each board title. 



AltaABA has now completed its third year as an affiliated chapter of the Association for Behavior Analysis International (ABAI) and first year as an official Society in Alberta. We successfully filed our first annual return with the Corporate Registry in December 2019 and we submitted our annual report to ABAI in March 2020. I would encourage every member to look at the online ABAI conference this year (due to the pandemic), happening very soon from May 21-May 25, 2020.

At the time of this report, there has been an increase in BACB active certificants in Alberta from 41 in May 2019 to now 49 as of this month. The growth of behaviour analysis in Alberta is still present but remains slow. We will continue to advocate and disseminate according to our mission statement. This year may be challenging in the midst of a post pandemic era, government budget changes for many families and organizations we support and adjusting to our own "new normal" lives. That being said, I am sure our executive board will rise to the challenge.

I am pleased to welcome our two newest board members: Sharon Randhawa - Member at Large and Christina Schofield - Student Member at Large. Both Sharon and Christina attended our meeting at the end of April and the entire board has been supporting their onboarding. I am excited to see their contributions in the year to come.
